Academic Fee Refund Policy : Admissions AY 2026-27

In consonance with the UGC Policy dated 12 June 2024, the refund will be processed as follows:

- (a) Upto 30 Sep 2026 : Full Fee Refund.
- (b) 01 – 31 Oct 2026 : Deduction of Rs. 1000/-.
- (c) Caution Money will be refunded in full irrespective of the date on which notice of withdrawal is received.

POLICY

Existing Student : Withdrawal of Admission

The policy is applicable for students of all programs from their Second Semester onwards. Students of first semester will be governed by the UGC/AICTE refund policy, as applicable, during the admission process.

Withdrawal

1. An existing student who has enrolled for courses at JIIT Noida and wishes to withdraw his/her admission, is required to submit the Application for Withdrawal of Admission to the Registrar's Office in the respective campus.
2. The student needs to complete the Institute 'Students No Dues Certificate' and submit it, along with the student's identity card, to the Registrar Office, between 10:00 am to 4:00 pm on any working day.
3. The application for withdrawal will be processed within 15 working days from the date of submission of the No Dues Form.
4. Refund of Academic fees as given below:

1	100%	Within 10 days of start of Semester
2	Nil	After 11 days of start of Semester

Deposition/Refund of Hostel Charges

Hostel

1. The full hostel charges are deposited by the students at the time of allocation of hostel.
2. Hostel accommodation allocated for one semester based on availability. Hostel allocation for 05 months in a Semester.
3. **Hostel charges.** As given in the admission brochure for the Academic Year (including NRI/FN/OCI/CIWGC candidates).

New Admissions - First Semester only

4. **Refund.** The students will be charged for hostel allocation in a proportionate manner as per occupation with part month being treated as full month for the hostel charges. Refund of hostel will be as follows:
 - (a) No deduction for students not allotted hostel accommodation.
 - (b) Proportionate charges will be deducted for students who withdraw from allotted hostel accommodation after the date of registration as mentioned in the Admission offer letter.
 - (c) On hostel cancellation, rate per month (as applicable) with part month treated as full month will be charged.
 - (d) Excess amount deposited by the students, if any, as hostel charges, will be reflected as advance at the end of Sem.
5. Second Semester Onwards. Rules at para 6 onwards will be applicable.

Existing Students

6. Hostel charges to be deposited by students on allocation of hostel. Proportionate hostel charges for subsequent allocation of hostel, based on availability (for eg, if hostel allocated in Sep/Feb, hostel charges from Sep/Feb onwards will be applicable).
7. The refund of hostel charges shall be as given below:
 - (a) Full hostel charges refunded if hostel not allotted/not occupied till the scheduled date of Registration as per academic calendar.
 - (b) In case of cancellation of allotted hostel accommodation after scheduled date of registration, the hostel charges will be deducted as follows:

- (i) Upto 31 Aug / 31 Jan – 20% deduction.
 - (ii) Upto 30 Sep / 28 Feb – 50% deduction.
 - (iii) From 01 Oct / 01 Mar onwards – No refund.
- (c) If a student is debarred from the hostel due to any disciplinary action, hostel charges will not be refunded.
8. The Hostel charges are subject to revision.
9. The above policy is effective from 01 Mar 2026.
